

There are many items you can pay for with your reimbursement account. Use this list to determine what items or services are eligible for reimbursement with your Surency Flex account. The following reimbursement accounts are shown on this list:



- Flexible Spending Account (FSA)
- Health Savings Account (HSA)
- Dependent Care Flexible Spending Account (DC FSA)

**SEARCH TIP:** Hold down Ctrl+F in order to easily search for expenses.

There are several types of accounts that are not included in the list because the eligible expenses vary between employers. These accounts may only allow you to be reimbursed for dental expenses, only vision, both, premiums only, etc. These variable accounts include Health Reimbursement Arrangements (HRA) and Limited Purpose Flexible Spending Accounts (LP FSA). ### A few things to keep in mind:


- **Always keep your receipts.** We may need you to submit your receipt to substantiate your claim or the IRS may require it to verify certain expenses.
- Only expenses incurred **DURING YOUR PLAN YEAR** are eligible for reimbursement.
- Even if an item is listed as eligible, **you may still need to substantiate your claim** with a receipt or other documentation.
- If an item contains an active medical ingredient, you will usually need a **prescription** from your doctor to be reimbursed for that expense.
- The following symbols indicate if an expense is eligible, requires a prescription or letter of medical necessity, or is not eligible:

 = Eligible Expense      **LMN** = Eligible with Letter of Medical Necessity from your Provider      **R<sub>x</sub>** = Eligible with Prescription       = Not an Eligible Expense

Adoption (medical expenses for adopted child)	✓	✓	⊘	Medical expenses incurred by your adopted child who is claimed as a dependent are eligible for reimbursement. Care must be for the adopted child and incurred while the child qualifies as your dependent. No fees associated with the adoption process are eligible for reimbursement.
Adult Day Care	⊘	⊘	✓	Adult Day Care may be eligible for reimbursement under a DC FSA when the adult is physically or mentally incapable of self-care, is a qualifying tax dependent of the account holder, and allows the accountholder and their spouse to be gainfully employed or to be seeking gainful employment.
After-School Care or Extended Day Care Programs	⊘	⊘	✓	Eligible for reimbursement with a DC FSA for the care of qualifying individuals and when it allows the accountholder and their spouse to be gainfully employed or to be seeking gainful employment.
Agency Fee for Child Care	⊘	⊘	✓	Eligible with a DC FSA when the child care is for a qualifying dependent of the accountholder and when it allows the accountholder and spouse to be gainfully employed or to be seeking gainful employment.
Air Conditioner/Air Purifiers	LMN	LMN	⊘	The primary purpose must be to treat or alleviate a medical condition, and the expense must not have been incurred “but for” the condition. If it is attached to a home (such as central air conditioning), only the amount spent that is more than the value added to the property will be eligible for reimbursement.

Airfare Related to Medical Treatment	✓	✓	⊘	You must submit information and documentation to prove that the airfare is in fact related to medical care.

Alcoholism/Drug/Substance Abuse Treatment	LMN	LMN	⊘	Eligible expenses include: inpatient treatment and outpatient care, including support groups.

Examples: electro-static air purifier, humidifier, home air conditioners, pillows, mattress covers, vacuum cleaners, etc. The reimbursable amount is limited to the excess cost of the special item when compared with a normally priced item and only when the primary purpose for diagnosis, treatment, mitigation or cure of a disease.

Batteries for Medical Devices	✓	✓	⊘	Expenses paid for the purchase of batteries are eligible for reimbursement when they are used for the sole purpose of an item that is also eligible. This includes hearing aids, blood pressure machines, wheelchairs, heart defibrillators, etc. Request for reimbursement should include a description of the item the batteries are purchased for. General use batteries are not eligible for reimbursement.
Bed Pan/Bedside Commodes	✓	✓	⊘	
Bed Wetting Aids	✓	✓	⊘	Eligible when purchased for the treatment of incontinence in an older adult or child – infant diapers are not eligible for reimbursement. Bed wetting aids include overnight underpants, absorbency pads, etc.
Before and After-School Care	⊘	⊘	✓	Child must be under age 13 or one who is incapable of self-care and can be claimed on your Federal Income Tax return. The expense may be covered under a DC FSA if specific requirements are met, including that the guardian(s) are enabled to be gainfully employed during the time a qualifying child is cared for, are full-time student(s) or are searching for gainful employment.
Behavioral Modification Programs	LMN	LMN	✓	May be eligible for reimbursement with an FSA or HSA when required for the treatment of a specific medical condition. For a DC FSA, behavioral modification programs are eligible for reimbursement if they are for a qualified child or relative and allow the parent or guardian(s) to be gainfully employed, search for gainful employment or be a full-time student(s).

Boutique Practice Fees	⊘	⊘	⊘	Monthly or annual fees that your provider may charge for improved access, 24/7 availability and more “personalized” care are not considered medical care and cannot be reimbursed. Fees for medical services actually received are eligible for reimbursement.

However, medical costs related to the removal of breast implants that are defective or are causing a medical problem are reimbursable.

The cost of permanent improvements that increase the value of your property may be partially reimbursed. The cost of the improvement is reduced by the increase in the value of your property. Capital expenses can include entrance and exit ramps, widening doorways, kitchen modifications, installing railings, etc. Expenses must be directly related to the medical condition. Refer to IRS Publication 502 for additional information.
Car Changes for Health Reasons	LMN	LMN	✗	Car changes for health reasons are generally eligible for reimbursement as they do not typically increase the value of the vehicle.
Car Modifications	LMN	LMN	✗	Car modifications for health reasons are generally eligible for reimbursement as they do not typically increase the value of the vehicle.
Car Rental for Medical Treatment/Services	✓	✓	✗	Mileage is also eligible for reimbursement. Must submit documentation of transportation, including the car rental invoice and a bill/receipt from your health care provider validating the reason for transportation.
